"Treat people the way you want to be treated, but even BETTER" is the motto of Golden Rule Services, a nonprofit, minority based organization in Oak Park. Founded in May 2003, Golden Rule Services is on a mission to reduce health, education, employment and juvenile justice disparities between people of color and the general population.

Clairmundo Sullivan, the founder of Golden Rule Services, says, "Our current focus is addressing the disproportionate rate of HIV within the local African American same gender loving community. To respond, we created the 'Men's Soul Food Project,' Sacramento County's only HIV prevention program created by and for local African American same gender loving men." The project provides local African American same gender loving men with multisession, group-level HIV prevention interventions. Participants are provided authentic soul

food, raffles and gift certificates for their participation and support of the project. Golden Rule Services is also currently subcontracting with the County of Sacramento to design posters, handbills, and brochures for the local African American same gender loving community, and has increased its HIV outreach to include bar outreach and HIV prevention via the Internet.
